# (15) Description of equipment

The Rotary valve is an equipment suitable for dosing and/or transferring (by means of a compressed air flow) different materials in the form of powder or granule (either inert or combustible) through the transport pipes till the area of use and/or to the storing area.

The allowed combustible powders are classified ST1 with a minimum ignition energy MIE > 3 mJ. The Rotary valve is not an isolating element for the propagation of the explosion.

Permissible range of ambient temperature: -20 °C to +40 °C.

Maximum product temperature: +100 °C

Maximum pneumatic transport temperature: +100 °C
